

Agri-GVC context and decent work

- Global agri-food value chains: dominance of large retailers and intermediaries
- Purchasing practices (delivery, cost, private standards): key challenge for suppliers
- Workers provide 'buffer' against buyer pressures
- Women often significant % of labour: mainly casual and smallholder
- Civil society campaigns over poor labour conditions – including on gender
- ILO Decent Work: employment, rights, social dialogue and protection
- UN Guiding Principles: states protect, companies respect, remedy for workers

- GVCs context rapid change
 - Rise of South-South trade
 - Regional and domestic value chains (DVC) & retailers
- Do private social standards apply in DVCs?
 - Mixed: some yes, most retailers rely on legislation
 - Many supply GVCs (with standards) and DVCs
 - Some private social & sustainability standards
- What are implications for workers/gender?

Kenyan Horticulture DVC

- Retail transformation within Kenya
- Horticulture GVC & DVC intersect with local markets
- Kenyan legal context changing:
 - Revised Constitution 2010; Adopted UNGP 2016 (inc. labour focus)
- Public horticulture standard (KS1758) 2019
 - Driven by : EU 'MRL' crisis & rising Kenyan cancer rates
 - Applies to GVC and DVC // GlobalGAP, ETI & RA
 - Initial focus on traceability & product standards... social?
- Wage workers & smallholders... women?

Future prospects for workers?

- Challenging times de-globalization?
- GVC/DVC deflects pressures: diverse markets
- Some private social standards in agri-food DVCs
- Public legislation focusing on agri-food GVC/DVCs playing greater role
- Context matters: variations by product/country
- Kenya case indicates mixed outcomes for workers and smallholders, including women
- Gender gulf between policy and implementation
